

Background

Dear customers.

Obtaining information about a service is the first step in a customer's journey, as it ensures that the service is applied for correctly and completed as quickly as possible at the least cost. Therefore, the Abu Dhabi Judicial Department has been keen to issue a comprehensive service guidebook, which is constantly updated to provide the customer with the basic information including:






