

- **08** The next step is to upload the document that needs to be notarized. Please select "Upload your own Clauses" and upload the document. The document must be in PDF format.

- **09** Upload all your supporting documents.
- **10** Review all the information and ensure that everything is correct. Once satisfied with the information, select "Submit request" and pay the court fee.
- 11 The request will be confirmed and you will be given the reference number to follow up.
